Educational Objectives Drs. Spanggaard and Dowling:

- Recognize clinical indicators for possible violence.
- Differentiate and define the common types and rates of workplace violence in psychiatric practice.
- Integrate simple steps that can improve safety as a mental health clinician.

Educational Objectives Dr. Voeller:

- Recognize the genetic, neurological, and environmental factors that underlie childhood learning disabilities and contribute to mental health issues in adulthood.
- Identify factors that affect the learning-disabled child's resilience and successful adaptation and contribute to poor adjustment and dysfunction in adulthood.
- Formulate specific questions that help to identify a childhood history of a learning disorder when interviewing adult patients.

Educational Objectives Messrs. Abate and Miller:

- Summarize the key legislative issues affecting the practice of psychiatry and other physicians.
- Distinguish the importance of physician involvement in the development of laws and regulations that impact the practice of psychiatry and mental health parity.
- Identify legislative issues on the horizon and effective ways in which to become involved at a grassroots level.

Educational Objectives Dr. Chan:

- Describe online practice delivery options, including telemental health video visits.
- Critically evaluate consumer and professional technologies for clinical practice and business operations.
- Discuss the challenges of developing, securing, and testing connected health technologies.

- Identify how telemedicine can reduce physician burnout.
 - Examine how EMR usability can be improved to enable better quality care.
 - Assess how culture change in health systems can improve physician well-being.
- Educational Objectives Dr. Jain:
- List tasks that glutamate performs and how in various psychiatric disorders this negatively impacts outcomes.
 - Apply this emerging understanding to various currently, and soon to be released, pharmacological interventions.
 - Assess how this emerging knowledge base regarding glutamate can be used in daily clinical practice to improve outcomes.
